The board (the “**Board**”) of directors (the “**Directors**”) of Hypebeast Limited (the “**Company**”) hereby announces that on 28 June 2019, the Company granted a total of 27,800,000 share options (the “**Share Options**”) to subscribe for 27,800,000 ordinary shares of HK\$0.01 each of the Company (the “**Shares**”) to 26 eligible persons (the “**Grantees**”) subject to the acceptance of the Grantees, pursuant to the share option scheme adopted by the Company on 18 March 2016.
